#### TOWN BOARD MEETING

Supervisor Ed Lachterman called the meeting to order.

#### **EXECUTIVE SESSION**

Upon motion made by Councilwoman Haughwout, seconded by Councilman Murphy, the Town Board moved into Executive Session to discuss negotiation and/or litigation matters. Upon motion made by Councilwoman Haughwout, seconded by Councilman Murphy, the Town Board moved out of Executive Session and proceeded with the meeting.

#### PLEDGE OF ALLEGIANCE

The Kavovit Family led the Pledge of Allegiance.

### **MOMENT OF SILENCE**

Supervisor Lachterman asked for a moment of silence to pray for those who are fighting to end to the strife in the world and to pray for those who are struggling with depression that they may find the help they need. He also asked to remember our first responders for all they do for our community, as well keep in our thoughts the members of our Armed Forces who fight for our freedom every day.

### REPORT FROM THE TOWN SUPERVISOR

Supervisor Lachterman reported on recent Town events and announcements, including the following:

- There was an issue at a home in Yorktown where the police were called and responded to people unconscious, and those with nausea and headaches, as a result of carbon monoxide. He urged residents to check their carbon monoxide monitors to make sure they are working properly and batteries are changed.
- Supervisor Lachterman held up a photo and said that there is a missing 15-year-old teenager from Mohegan Lake by the name of Violet. She left her home of her own volition with a friend but did not take her cell phone. If you see her, please notify the police.

Councilman Murphy acknowledged Laura, Lisa, and Dave who were very good friends of Robert Kavovit, as well as schoolteachers in our district. He said that they were very instrumental in getting the following proclamation for Fifteen for Life.

Councilman Murphy said a few words about Robert Kavovit, primarily that he was a family man who would do anything for his wife, children, parents, and siblings. He said that Robert won three state championships in high school and one NCAA championship in college. Councilman Murphy said that the lacrosse community and the Kavovit family have come together to bring mental health awareness to the forefront instead of shying away from the issue by creating Fifteen for Life. Councilman Murphy invited Robert Kavovit's friend Dave to read the following proclamation:

### ROB KAVOVIT – FIFTEEN FOR LIFE

Whereas, Rob Kavovit was a 45-year-old all-American loving husband, father, son, uncle, and mentor dedicated to his family, enjoying life; and

Whereas, Rob was a Yorktown native, played lacrosse in Yorktown High School and Syracuse University, and wearing the No. 15 was a significant number for rob, as it represented the Kavovits – one girl and five boys, and his parents anniversary date; and

Whereas, Rob later moved to Stuart, Florida with his wife Marion and two sons, Landry and Luke, working as a physical therapist, and coaching both high school and youth lacrosse until losing his battle with depression on March 16, 2021; and

Whereas, with an average of 132 suicides daily, each one directly impacts at least 100 additional people, including family, friends, neighbors, coworkers; the ripple continues; and

Whereas, there are many people like Rob, going through life working, caring, and loving yet suffering from depression; we must equip people of all ages to be comfortable enough to seek help without feeling embarrassed; and

Whereas, the *FIFTEEN FOR LIFE* mission is a grassroots movement to raise awareness in a fresh and honest way about mental health, with a goal of reaching 15,000 people;

Now, Therefore, Be It Resolved, that I, Edward A. Lachterman, along with the Town Board of the Town of Yorktown do hereby proclaim May 15<sup>th</sup> as FIFTEEN FOR LIFE DAY.

Dave thanked the Town Board for presenting the proclamation. He said it is still hard after three years. Supervisor Lachterman said a few words on the value of Fifteen for Life.

Supervisor Lachterman read the following proclamation:

AMYOTROPHIC LATERAL SCLEROSIS (ALS) AWARENESS MONTH PROCLAMATION WHEREAS, Amyotrophic Lateral Sclerosis (ALS), known by many as Lou Gehrig's disease, is a progressive fatal neurodegenerative disease in which a person's brain loses connection with the muscles, slowly taking away their ability to walk, talk, eat, and eventually breathe; and

WHEREAS, every 90 minutes someone is diagnosed with ALS and someone passes away from ALS; and

WHEREAS, on average, patients diagnosed with ALS only survive two to five years from the time of diagnosis; and

WHEREAS, ALS has no cure; and

WHEREAS, people who have served in the military are more likely to develop ALS and die from the disease than those with no history of military service; and

WHEREAS, securing access to new therapies, durable medical equipment, and communication technologies is of vital importance to people living with ALS; and

WHEREAS, clinical trials play a pivotal role in evaluating new treatments, enhancing quality of life, and fostering assistive technologies for those living with ALS; and

WHEREAS, we celebrate the 10th Anniversary of the Ice Bucket Challenge through a renewed commitment to galvanize public awareness and support funding leading to significant investments in ALS research; and

WHEREAS, the ALS Association, as the largest philanthropic funder of ALS research globally, has committed over \$154 million to support more than 550 projects across the United States and 18 other countries; and

WHEREAS, our commitment to accelerating the pace of discovery remains unwavering, fueled by the hope that one day, ALS will be a livable disease for everyone, everywhere, until we can cure it; and

WHEREAS, ALS Awareness Month increases the public's awareness of people with ALS' dire circumstances, and acknowledges the terrible impact this disease has, not only on the person but on his or her family and the community, and recognizes the research being done to eradicate this disease; and

Now, therefore, I, Town Supervisor Edward Lachterman, along with the Town Board do hereby proclaim the month of May 2024 as ALS Awareness Month and call upon all Americans to join in supporting ALS research, advocating for increased funding, and standing in solidarity with those affected by this relentless disease.

Supervisor Lachterman spoke of ALS and that it is a horrible disease. He spoke of those he has met who had or have ALS, such as the man who began the Ice Bucket Challenge.

# <u>DISCUSSION OF THE REVISED PROPOSED LOCAL LAW TO AMEND CHAPTER 45 OF THE CODE OF THE TOWN OF YORKTOWN ENTITLED "ETHICS"</u>

Town Attorney Adam Rodriguez said that there were some technical changes and an addition that has not changed the scope of the law. He said that a referral was added to include the Town Attorney if the Ethics Board finds any issues in the course of an investigation that were not brought to them in a complaint. He said that it was also made clear that if for some reason there is a conflict of interest for the Town Attorney to be involved and the Ethics Board needs counsel, they can ask that the Town Board appoint counsel.

All those present having been given the opportunity to be heard and there being no further discussion, the hearing was closed. Upon motion made by Councilman Murphy, seconded by Councilman Esposito, and carried.

## ADOPT LOCAL LAW NO. 3 OF 2024 TO AMEND CHAPTER 45 OF THE CODE OF THE TOWN OF YORKTOWN ENTITLED "ETHICS"

#### **RESOLUTION #290**

Upon motion made by Councilman Murphy, seconded by Councilman Esposito,

Whereas, a public hearing was held on the 19<sup>th</sup> day of March 2024 pursuant to notice duly published as required by law to amend Chapter 45 of the Town Code entitled "ETHICS"; now, therefore, be it

Resolved that Local Law No. 3 of 2024 be and is hereby adopted.

Lachterman, Esposito, Haughwout, Murphy Voting Aye Local Law No. 3 was thereupon duly adopted.

# DISCUSSION OF THE REVISED PROPOSED LOCAL LAW TO AMEND CHAPTER 275 OF THE CODE OF THE TOWN OF YORKTOWN ENTITLED "VEHICLES AND TRAFFIC" (ALL-TERRAIN VEHICLE AND OFF-HIGHWAY MOTORCYCLE LAW)

Town Attorney Adam Rodriguez said that a significant amount of changes were made to the proposed local law and a new public hearing would not be uncalled for. Councilman Esposito said that he felt it should be brought back to the public. He said that there was one issue that came up to make the actual offence a misdemeanor because of observation of the infraction. Supervisor Lachterman said the question of not only the breaking of the law having a criminal element to it but also having high fines. He asked Mr. Rodriguez that the penalty should be commiserate to the damaged caused. Mr. Rodriguez said the penalty for a first offense is up to \$500. He said that, in his opinion, the penalties are severe enough. Councilman Esposito asked if the Town made it a misdemeanor, it does not necessary mean the person is charged with a misdemeanor and Mr. Rodriguez said that in general the police have the discretion to charge you with whatever they feel is appropriate. Councilman Esposito suggested putting the proposed law back into referral so that the public has a chance to comment. Supervisor Lachterman agreed.

The Town Board decided to send the revised proposed law out for referral.

All those present having been given the opportunity to be heard and there being no further discussion, the hearing was closed. Upon motion made by Councilman Esposito, seconded by Councilman Murphy, and carried.

### **DISCUSSION OF THE TOWN COUNCIL VACANCY**

Supervisor Lachterman said he is in favor of a special election to fill the Town Council vacancy so that the public has a voice and that it is an important part of the democratic process. Councilman Esposito said that New York State passed a law that elections as of 2026 will be held only on even years. He said that he does not think that this is beneficial to small towns because small elections are going to be drowned out by the bigger seats of the General Election. He is also in favor of holding a special Election. Supervisor Lachterman said that the Special Election will be held on July 23, 2024.

## SPECIAL ELECTION FOR THE TOWN COUNCIL VACANCY TO BE HELD JULY 23, 2024 RESOLUTION #291

Upon motion made by Councilman Esposito, seconded by Councilman Murphy,

Whereas, "Whenever a vacancy shall occur or exist in any town office, the town board or a majority of the members thereof, may appoint a qualified person to fill the vacancy... If the appointment be

made to fill a vacancy in an elective office, the person so appointed shall hold office until the commencement of the calendar year next succeeding the first annual election at which the vacancy may be filled."; and

Whereas in November 2014, by referendum, the Town enacted section 65-9 et. seq., in regard to filling vacancies to elective offices within the Town of Yorktown wherein it allows the following:

"Within 30 days after the occurrence of a vacancy in an elective office subject to this article, the vacancy may be filled by Town Board appointment. If an appointment is not made within 30 days, the vacancy may be filled by either:

- A. Special Election called by the Town Board, to be held not less than 60 days and not more than 90 days from the date the Town Board decides to call for a Special Election; or
- B. In the next General Election, whichever will allow the vacancy to be filled in the shortest space of time reasonably possible."

Whereas, upon a special election, the unexpired term of the vacancy is filled; and

Whereas, the aforementioned section of the Yorktown Town Code was enacted prior to the changes made to the New York State Election Law making any special election subject to the provisions of early voting; and

Whereas, in order to accommodate early voting within the time frames set forth in the Yorktown Town Code; now

Therefore Be It Resolved, that pursuant to Section 65 et. seq. of the Town Code of the Town of Yorktown, the Town Board hereby sets July 23, 2024 as and for the date upon which a special election shall be held to allow for the election to the unexpired term of Town Councilman, as previously held by Edward A. Lachterman; and

Be It Further Resolved, that said Special Election (including day of voting and early voting) shall be administered by the Westchester County Board of Elections in accordance with all applicable laws.
