Meeting of the Town Board, Town of Yorktown held on Tuesday, April 30, 2024 at 363 Underhill Avenue, Yorktown Heights, New York 10598.

TOWN BOARD MEETING

Supervisor Ed Lachterman called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Councilwoman Haughwout, seconded by Councilman Esposito, the Town Board moved into Executive Session to discuss individual personnel matters and/or litigation matters with the Town Attorney. Upon motion made by Councilwoman Haughwout, seconded by Councilman Esposito, the Town Board moved out of Executive Session and proceeded with the meeting.

PLEDGE OF ALLEGIANCE

Town Clerk Diana Quast led the Pledge of Allegiance.

MOMENT OF SILENCE

Supervisor Lachterman asked for a moment of silence to remember our first responders, members of the military who keep us safe every day. He also wished for a peaceful resolution to all of the ongoing strife in the world and to hate, especially the increase in antisemitism.

INTRODUCTIONS

Members of the Town Board introduced themselves, as well as Town Clerk Diana Quast, and Adam Rodriguez, Town Attorney.

REPORT FROM THE TOWN SUPERVISOR

Supervisor Lachterman reported on recent Town events and announcements, including the following:

- *Announced that today, April 30, 2024, the Westchester County Board of Elections certified the April 16, 2024 Special Election and confirmed him as Town Supervisor.
- Thanked all who came out to vote in the Special Election (almost 8,000 votes cast)
- Congratulations to the Yorktown Volunteer Ambulance Corp and the Mohegan Lake Ambulance Corps on their new line officers. YVAC celebrated their 61st year in operation.
- Battle of Yorktown was held on April 20 and Yorktowners collected approximately 11.1 tons of garbage.
- The Mobile Shredder was out on April 26 and served 233 cars collecting 33.82 tons of paper for shredding.
- Arbor Day Celebration was held on April 26 and the winning posters done by the Town's fourth and fifth graders are hanging in the Town Board Room.
- A job fair will be held May 1 at the AACCCC from 10:00 am to 2:00 pm held in conjunction with Westchester County and the Chamber of Commerce.
- Announced that May is Jewish American Heritage Month and on May 8, for Yom Hashoah, the Town will be holding its Holocaust Remembrance Event at 7:00 in the Town Board Room. The guest speaker is Annie Leiser-Kleihaus, a Polish immigrant who left her home in Belgium during World War II.
- Saturday, May 11 at 10:00 am, is the renaming of Granite Knolls in honor of Supervisor Tom Diana.

REPORT FROM TOWN OFFICIALS

Members of the Town Board reported on recent Town events and announcements.

Councilman Esposito announced the following:

- 15 for Life Event held on April 27, which is a "shed the shame" program for depression and mental illness. Councilman Esposito related the story of how the program began in honor of a former Yorktown High School student, Rob Kavovit.
- Yorktown Chamber of Commerce Spring Market was a success.
- Game Day Grille held an "Autism Speaks Day" that raised money for "Scarlet Inspired" program that brings awareness to autism and is donated to the Autism Foundation.
- YVAC held their Open House.
- May 11th an Eagle Scout Recognition will be held for Joshua and Jacob Erenberg.

Councilwoman Haughwout announced the following:

- The Town is looking for lifeguards, attendants, and counselors for the Town Camp. Please check out the Parks & Recreation webpage.
- Announced that both Hilltop Hanover Farm & Environmental Center and Meadowbrook Farm, which are opening soon.
- May 11 will be the Yorktown Garden Club's Mother's Day Sale and native plants will be sold.
 The sale will be located in front of the former KMart store. The hours are 8:00 AM to 2:00 PM
- The John C. Hart Memorial Library is hosting a Talk and Learn with the Wolves program for ages five and older on May 4 from 10:30 AM to 11:30 AM.

Councilman Murphy announced the following:

• FamJam Event raised approximately \$30,000 for local charities. The event was sponsored by small businesses in Yorktown and was assisted by several Town departments. They are giving out six \$1,000 scholarships to high school seniors (see www.famjam.com for the scholarship application). Some of the money raised is being given to the Yorktown Teen Center and for the purchase of paint for the Grange Fair.

Supervisor Lachterman also announced that local historian and author Dave Rocco is involved with the Fireboat McKean Preservation Project. The John D. McKean Fireboat, which has been retired, was one of the boats that helped put out the fires at the Twin Towers on 9/11. It also responded to the emergency landing of the plane on the Hudson River. He said that they are looking to raise funds for its preservation and if anyone is interested, they may contact his office (914-962=5722, ext. 200) or view the website at www.fireboatmckean.org.

Councilwoman Haughwout added that Teatown Reservation is also holding a plant sale on Friday, May 10 from 3:00 PM to 7:00 PM and Saturday, May 11 from 9:00 AM to 2:00 PM.

ROCHAMBEAU FESTIVAL – HERITAGE PRESERVATION COMMISSION

Lynn Briggs, chairperson of the Heritage Preservation Commission and NYS Chair for the Washington Rochambeau Revolutionary Route Organization (W3R), said that she is also part of nine state chairs, part of the United States organization that is committed and focused on commemorating the anniversary of our independence from Britain in 2026 (250th anniversary). She came before the Town Board to discuss the upcoming Rochambeau Festival being held at the Grange (also known as Rochambeau Park) on May 18 & 19 and is hosted by the Yorktown Heritage Preservation Commission (YHPC), Yorktown 250, the Grange, and W3R-NY. It is a totally immersive event into the Revolutionary War history and what happened in Yorktown. Ms. Briggs discussed many of the events that will happen on those days, as well as many of the exhibitors who will be present. She asked Supervisor Lachterman if they could ask Thompson & Bender to help them promote the event and he said that they have already been contacted. She handed flyers to the Town Board for the event.

POET LAUREATE

Councilman Esposito read an original poem by John McMullen, Poet Laureate, entitled "April Was a Weird Month."

CONVENE PUBLIC HEARING TO CONSIDER A PROPOSED LOCAL LAW AMENDING CHAPTER 275 "VEHICLES & TRAFFIC" REGARDING PARKING ON ROUTE 6 SERVICE ROAD

Supervisor Lachterman convened a public hearing to consider amending Chapter 275, Section 275-4(J) of the Code of the Town of Yorktown by adding the following Section 275-4(J)(7):

It shall be unlawful to park a commercial vehicle, including trailers with or without trailer registration plates, on the N.Y. Route 6 service road adjacent to the Town of Yorktown's Golf Course from (41.332393, -73.815373) to (41.331188, -73.810719), unless said vehicle is engaged in the process of delivery or rendition of services to the Town's Golf Course.

Town Attorney Adam Rodriguez said this is a fairly simple addition to the Town Code. He addressed the comment received by Mr. Jay Kopstein who was concerned that the language in the amendment could be read to mean that the Town is authorizing unregistered commercial vehicles to park on the service road. Mr. Rodriguez said that he does not read it this way and to do that would violate other sections of the Town Code, not to mention NYS Code. Mr. Rodriguez said he has prepared a modification to the proposed law to address the issue and make clear that this is not what is happening. He said that the proposed law should say at the end "unless said commercial vehicle is properly registered, has properly affixed license plates, and is engaged in the process of delivery or rendition of services to the Town's Golf Course."

The following members of the public spoke:

- Jay Kopstein, resident, said the new draft was not on the Town's website, so he could not intelligently comment on the change. Town Clerk Quast said that it had not been given to her office. He asked that if it was not in the Town Clerk's office, how the Town was having a public hearing on a piece of legislation that the public did not have a chance to read. Mr. Rodriguez said that he was changing the law now to address public concern, specifically Mr. Kopstein's. Mr. Kopstein said that it should be posted on the website for the public to read because that it what they are supposed to do. Supervisor Lachterman asked Town Clerk Quast if none of the proposed legislation had been posted and she said that all proposed legislation is posted but the Town Attorney's amendment that was made to address Mr. Kopstein's concerns was not received by her office and that is why he read it off earlier because if the Town Board were to do the public hearing, you would amend it to adjust to that verbiage. She said that this is why it was not sent ahead of time because Mr. Rodriguez did not know if the Town Board would want it. Town Clerk Quast said that typically before a public hearing is held, her office sends all comments received out to everyone so that you have them in advance of the Town Board meeting to read them. She said that Mr. Kopstein did send his comments ahead of time. Mr. Rodriguez said that if the Board would look at the comments and tell him they that need to be addressed, he would revise the amendment, and the Board would vote on it. He said that he is proposing the change now in front of the Town Board during the public hearing. He said that nobody is voting on it tonight because a change has been made to the original proposed local law. Supervisor Lachterman said the proposed change would be added and the law would be posted for the public's review.
- Mark Lieberman, resident, said that last summer there were cars parked on both sides of the shoulder on the access road. He said that no emergency vehicles would be able to get through and he thinks that the law should include all vehicles, not just commercial vehicles.
- Dan Strauss, resident, asked where all of these vehicles suddenly come from that are parked there and what would prevent them from parking somewhere else? He asked if anyone addressed the issue with the owners of the vehicles. Mr. Strauss said it was discussed about emergency vehicles being able to get through on the access road or specific access provided in the event of an emergency.

Supervisor Lachterman said that they have tried contacting the leasing companies that own the vehicles. He said that there is a question as to whether or not the Town has jurisdiction based on the fact that the access road is on a state road. He said part of the issue is that when tractor-trailers are using the access road, there is no room for vehicle parking. He said that if you own a commercial vehicle, you are required by Town Code to have a special use permit to park it on your own property and it needs to be screened and covered. Supervisor Lachterman said that, apparently, these are people trying to avoid that or are not from Yorktown, see a Park and Ride, and just decide to park there. He said that having this law would enable them to ticket a vehicle and enforce the law.

Councilman Esposito said that people were parking right up to the edge of the opening and now banning that would help emergency vehicles gain entry. Councilwoman Haughwout asked if these vehicles would now be able to be ticketed and towed and Town Attorney Rodriguez said yes.

- Mr. Kopstein said that if the Town restripes or changes the rules, you have to modify the Town Code as to pavement markings and signage, otherwise, it is not enforceable.
- Mr. Strauss said that if there is an issue about fire trucks not being able to get to the restaurant, he finds it hard to believe the Town would allow a restaurant to be located there due to public safety concerns.

Supervisor Lachterman said that the Fire Department can come in, park on the road, and bring hoses down. He said that the building is close enough to the road for them to access with hoses. He said that, as Mr. Kopstein pointed out, striping alone is not enough; legislation has to pass so that it can be enforced.

Supervisor Lachterman introduced Parks & Recreation Superintendent James Martorano to speak about safety concerns at the golf course. Superintendent Martorano said that on August 11, 2023 he and Supervisor Diana did a walk-through of the property with the Lake Mohegan Fire Department to determine if a fire truck could safely enter the property. He said there was recommended striping but they were not sure if it could be done, as Route 6 is a state road. He said that eventually they were able to put the striping down. He said they measured out the area for turning and brought a fire truck in to make sure it would work and there was no problem with the turn radius.

Councilman Esposito wanted to make sure that it is understood that these are two separate issues: the commercial vehicles that change all the time; the other concern is that a fire truck could not get in. He said that this was addressed months ago with the fire department. Councilman Murphy said the Town needed to keep an eye on the situation. Councilman Esposito said that he believed the striping has been done because cars have not been parking at the edge where fire trucks would have to turn in to the property.

• Harold Gould, resident, said that if there is an emergency at the restaurant, emergency vehicles would be driving quickly and asked if that was taken into consideration.

Supervisor Lachterman said that our police and fire departments take safety into consideration when getting to a scene. He said there are no more high speed chases or racing to a scene.

- Dan Strauss said that he wanted to make it clear that he was not throwing out accusatory statements about people's lives. He said he simply feels that there should not be a situation where people's lives are in danger. He said the trucks are a separate issue.
- Mark Lieberman said that very often a trucker will sleep in their trucks and wanted to know if there would be a more severe penalty for that because he does not like the idea of people sleeping in their vehicles.
- Anthony Pichette, resident, asked if the Town monitors the vehicles that are parked there for a certain length of time. Supervisor Lachterman said that the vehicles do change; it is not always the same ones.

All those present having been given the opportunity to be heard and there being no further discussion, the hearing was closed. Upon motion made by Councilman Murphy, seconded by Councilman Esposito, and carried.

CONVENE PUBLIC HEARING TO CONSIDER A PROPOSED LOCAL LAW AMENDING CHAPTER 275 "VEHICLES & TRAFFIC" REGARDING TOWN SPEED LIMITS

Supervisor Lachterman will convene a public hearing to consider amending Chapter 275, Section 275-17(A) of the Code of the Town of Yorktown by amending in its entirety as follows:

No motor vehicles, motorcycles or other vehicles of any description whatever shall be run, driven or operated upon Town highways within the Town of Yorktown at a rate of speed greater than 30 miles per hour, except on the following Town highway, the speed limit shall be 40 miles per hour.

Underhill Avenue between the west side of Overhill Street and the point at which the entrance and exit ramps of the northbound side of the Taconic State Parkway intersect with Underhill Avenue

Section 275-17(B)(1) of the Code of the Town of Yorktown is hereby amended by adding the following public highway locations:

Aqueduct Road Hitching Post Woodfield Court High Ridge Road Baptist Church Road Rockwood Court

Town Attorney Adam Rodriguez said that this is a reduction in speed and the first part (17A) would reduce the speed limit to 30 mph and the remaining ones would be dropped to 20 mph.

Supervisor Lachterman reviewed where the changes were being made.

The following members of the public spoke:

- Jay Kopstein, resident, asked if a Traffic Safety Officer went along with these changes. He asked if the Town Board was aware that they would have to put up additional signage up not just for the new speed limit but to warn people that there is a change and give a reasonable distance in which to reduce their speed. He asked if the Town is making it more difficult to enforce the new speed limit because it is being changed. Supervisor Lachterman said that both of the Traffic Safety Officers are on the Traffic Safety Committee and are aware of the changes.
- Dan Strauss, resident, asked why these particular roads were being changed. Supervisor Lachterman said that the Town is required to list the speed limits of the roads in the law. He asked specific questions about the speed on Underhill Avenue.
- Sam Rosenfeld, resident, asked if the Town Board could state, unequivocally, that the change had nothing to do with the Underhill Farm project on Underhill Avenue. Supervisor Lachterman said it was not the developer but a private resident who requested the change, as well as residents on Cardinal Court.
- Martin Costello, resident of Underhill Avenue, said the change should go up past Anna Court. Supervisor Lachterman said he would make this suggestion to the Traffic Safety Committee, as they set the boundaries for the speed limits.

Councilman Esposito asked Supervisor Lachterman to speak about the Traffic Safety Committee. Supervisor Lachterman said the committee is made up of the Town's two Traffic Safety Officers (Rob Rohr & Max Ellsworth), Highway Superintendent Dave Paganelli, and resident Bill Bertram (who is also a Traffic Safety Officer for the City of White Plains). He said that he also sits in on their meetings, as well. He said that they take in the recommendations that come in from residents and go out and observe the area, and review the law to see if the recommendation may be done.

- Jay Kopstein said that New York City wanted to reduce speed to 20 mph on certain roads and had to get enabling state legislation and asked if these changes could be made without enabling state legislation. Mr. Rodriguez said that yes, the Town could.
- Anthony Pichette asked how roads could be added to this type of legislation. Supervisor Lachterman said he could send an email to either him or Highway Superintendent Paganelli so it could be considered by the committee.
- Harold Gould asked if drivers would have enough time to slow down to the new speed limit and would the signage take that into account. Supervisor Lachterman said, as Mr. Kopstein pointed out, there would have to be a "reduced speed limit" sign posted in advance of the new speed limit.
- Jay Kopstein said that Section 1622 of the Vehicle and Traffic Law specifically states that you cannot have a speed limit below 25 mph, except in a school zone. Mr. Rodriguez reviewed the section referred to and said that he would need more time to review this section.

All those present having been given the opportunity to be heard and there being no further discussion, the hearing was closed. Upon motion made by Councilman Esposito, seconded by Councilman Murphy, and carried.

Library Director Yvonne Cech introduced Tamarah Hyman, who is promoted to the position of Senior Library Clerk in the John C. Hart Memorial Library. Ms. Cech said that Tamarah has been with the library for the last two years and will be filling the Senior Library Clerk position due to a retirement on her staff. Ms. Cech said that Tamarah has been an incredible liaison with the public and has the respect of the entire library staff. Tamarah will be the supervisor of the Circulation Department, which is the heart and soul of the library.

Ms. Hyman thanked the Yvonne Cech and the Board for the opportunity and said she was excited for her new position. Ms. Hyman said she previously worked with the mentally ill/substance abuse/homeless population, as well as PetSmart with dogs.

OPEN FLOOR FOR PUBLIC COMMENT

The following members of the public spoke:

- Sam Rosenfeld, resident, said he would like to better understand what he has been reading about water usage charges and sewer taxes. He said that apparently there is a big inequity and he is not sure how long this has been going on and would like to know how long this is going to go on. Mr. Rosenfeld asked if it would be possible to identify those people who are benefitting from this inequity, especially if they are people with a conflict of interest.
- Martin Costello, resident, read a statement regarding Underhill Farm. He said many residents are not happy about all of the tree cutting that has been happening and is questioning if this activity is being done according to Town Code and wanted to know if they received all of their permits (Army Corps of Engineers, DEP, etc.) in order to proceed.
- Susan Siegel, resident, asked for an update on the sewer charge and the inequities that exist. She said that some homeowners are paying \$16.30 and others are paying more than \$100 for the same service. She asked, "Where's the fairness or rationale for having 5 different ways to assess the same sewer charge?" She asked when the sewer maintenance expenses would be straightened out so that the 4,000 taxpayers in the Hallocks Mill Sewer District are not subsidizing the 4,100 taxpayers in the Peekskill Sewer District. She asked, "Or is it the other way around? Who is subsidizing who?" She said that no one knows and it is time this account mess was straightened out. Ms. Siegel asked what the Town's plans are for straightening out the infrastructure problems in both sewer districts and asked if there are any specific plans for the Hallocks Mill Sewer District Extension besides just looking for grants. She asked about plans for the Hunterbrook Pump Station that could very well block the Toll Brothers project on Catherine Street that is projected to generate about \$1 million in revenue for the Town and Yorktown School District. Ms. Siegel said earlier in the month she sent the Town Board a report detailing all of these issues. She said the report is available in the Town Clerk's office. Ms. Siegel asked the Town Board what is being done about the multiple code violations taking place at the Fieldstone Manor development off Strawberry Road. She said she had asked about this at the March 19th meeting but has not heard back from anyone. She said the violations involve the conversion of the stone building into six apartments and a commercial event space and both conversions were done without the required building permits. She said that the event space is a violation of the zoning code, which does not allow a commercial use in that residential zone. Ms. Siegel said that after the violations were made public in December 2023, the Building Department issued a violation notice for the apartments on December 6, but as of April 17, the violation was still open and there is no record that a building permit or Certificate

- of Occupancy were ever issued for the apartments. She asked if apartments were occupied and if so, do they comply with the Planning Department resolution that required that two of the apartments conform to the Affordable Housing rent guidelines in the Town Code.
- Lynn Briggs, chair of the Yorktown Heritage Preservation Commission and chair of the NYS Washington Rochambeau Revolutionary Route Organization, said she is requesting that the Town Board take action to preserve any potential archeological artifacts that may be associated with the Rochambeau encampment [on Underhill Farm]. She said the YHPC has advised both the Planning Board and the Town Board over the last two and a half years that there is sufficient evidence to suggest that the encampment took place on, or in the proximity, of the Underhill Farm development. Because of this evidence, the developer was required to have an archeological monitoring plan in place while the ground is being disturbed. Ms. Briggs said, as mentioned by another resident earlier, that the ground disturbance has already taken place and is likely to continue, even before the monitoring plan is in place. She said that their monitoring plan is deficient. Ms. Briggs said the plan does not acknowledge the Revolutionary War encampment, nor does it acknowledge potential artifacts on the property or outline any potential battlefield techniques to rule, in or out, whether there is a presence of archeological artifacts, such as metal detection or ground penetrating radar. Ms. Briggs said that if this ground disturbance is allowed to continue before an adequate archeological investigation takes place, the Yorktown community might lose any possible archeological artifacts dating back almost 250 years. She said that monitoring that takes place after the ground has been disturbed is pointless. She said that as the Town Board is responsible for enforcing Town Code, the YHPC requests that the Town Board direct the staff to stop the ground disturbance now before any more takes place and it is too late. She also asked that the Planning Board be directed to address the deficiencies in the monitoring plan.
- Matt Talbert, Parks & Recreation Commissioner, said that it has just come to his attention that the alienation of parkland request for Homeland Towers' installation of a cell tower at 109 Granite Springs Road was never referred to the Commission. He requested that the project be recirculated back to them so they can review the documents.
- Dan Strauss thanked those who participated in the Battle of Yorktown. He also spoke about all of the trees being cut down in the name of progress. He also raised the issue of cutting the Town Board meetings down to three a month, which would probably make some of the meetings longer. Mr. Strauss requested that the meetings begin on time.
- Anthony Pichete said he appreciated the opportunity to speak at both the public hearings and Open Floor for Public Comment. He said that the librarians do a great job and hold wonderful events. He wished they received more funding. He said that someone came onto his property and removed his political signs and then spray painted the replacement signs. He asked that the Town Board speak to this issue because it can be a scary thing to have happen.

Upon motion made by Councilman Esposito, seconded by Councilman Murphy, Open Floor for Public Comment was closed.

Supervisor Lachterman asked Planning Director John Tegeder to address the Underhill Farm comments. Mr. Tegeder said that the developer has a tree permit for a particular area of the property. They are not allowed to remove stumps and none have been seen. He said that the Town Engineer has been going over to the property to make sure they are not exceeding what is allowed in the permit. He said that he does not believe that they have the DEP permit, but it should be coming in the next few days and that it is not unusual that the permit comes after the Planning Board's permit; it is standard practice. Mr. Tegeder said they do not have the Army Corps of Engineers permit, but like the DEP, it usually comes after the Planning Board's permit. He continued by explaining the process of permitting and what is permitted to occur, as well as the responsibilities of the Boards and the developer. Mr. Tegeder addressed the historic work issues. He said that under SEQRA, the Planning Board underwent a very robust review process and had all of the evidence that was provided to them and that they gathered themselves from commentary and produced an approval that would allow this development to take place with the preservation of the mansion. He said that this evidence allowed them to go forward and that there is not sufficient evidence of encampment on that property - the approval is clean. He said both the applicant and the Town had experts to investigate this claim. He said the disturbance that is happening as a result of the tree removal is superficial. He pointed out that part of the investigations included shovel tests – dig in the ground to see what is there – and this is done all across the site and no evidence was found. This information was also sent to New York State. Mr. Tegeder said evidence is when you find something; saying there may be something there is not evidence.

Supervisor Lachterman said the sewer issues have been issues that were kicked down the road by several administrations. He said that is based on how the sewer districts were formed, how much debt they incurred when they were built, which cannot be passed on to another sewer district. He said that right now they are looking into the feasibility of condensing the Town's seven sewer districts. Supervisor Lachterman said that he has spoken to the new Assessor about this and said that this is something that he would like to complete during his term as supervisor. He said that the pump stations (5) that are being reworked right now, the engineering plans have passed, and EDR (the consultant) is working on them. He said that the Town is prevented from continuing on the Hallocks Mill Sewer Extension because of the cost and needs to find additional funding and there is no choice but to wait for grants. He said that the State will not allow the Town to raise residents' taxes \$2,000-\$3,000 for sewers. Supervisor Lachterman said that they are currently working on the inflow that comes in to the sewers, which rises during the rainy season that leads to holes in the pipes and broken pipes. He said that this and other measures (smoke testing) are being done to insure the safety of the sewer system.

Councilman Murphy said that no member of the Town Board tolerates the divisiveness that has occurred, particularly addressing Mr. Pichete's concerns about the election signs. He said that whoever painted his signs should be criminally charged. Supervisor Lachterman said that he posted that this is what, unfortunately, happens every election and people should be more tolerant. Councilwoman Haughwout said that it is heartbreaking to hear about these types of incidents. She also apologized for the late meetings and said that there are many questions that need to be asked and answered. Councilman Esposito said that he was sorry about what happened to Mr. Pichete but there is little they can do after the fact. He said that very often the Town Board members are pointed to as responsible for this type of behavior; however, that is not true.
